

Sabor Kustoms Car Club has made a use request to Spreckels Memorial District to host a car show/fundraiser/art display to be held at Spreckels Veterans Memorial Building. All aspects of this event will be performed as a normal use of our facility and contained within the Memorial Building auditorium and our fenced in parking lot. But because parking for attendees is planned for the non-residential sides of Nacional Avenue and Fifth Street, which could impact Spreckels residents, we suggested this should be run by the Special Events Task Force for possible permitting requirements.

The parking plan would be the same as we do for the encroachment permit for the Spreckels 4th of July Celebration. But unlike the 4th of July, there will be no road closures. I oversee the encroachment permit for the Spreckels 4th, as well as the Carmel Valley Santa's Fly-In, so I will be assisting Sabor Kustoms as needed through the Special Events process. A few notes of clarification.

Please note most of the attendees will be the same people that enter their cars in the show which will be parked in the parking lot. We expect that "spectators" will park their cars around the Spreckels park and around the memorial building. We don't expect there to be many more "spectators" cars parking around the town than the Toro bulls have during their practices on week days.

Serving alcohol is not important to our event. This service was simply added to benefit the VFW, if it is going to hinder or be a hurdle for us to hold this charity car show event at the Spreckels Memorial building we would prefer not to have alcohol sold at our event. Sabor Kustoms nor Jacobs Heart will not benefit at all from alcohol sales at our car show event.

This is simply a car and art show to benefit Jacob's heart 100%. We will be collecting \$25 gas cards from all car show participants which Jacob's Heart has identified as the item they most need, to help families with the transportation of their children to hospitals for cancer treatments.
